PRESIDENT'S REPORT

1998 has been a very challenging year here at the Glendale Lyceum. Member involvement in various activities, the defining essence of this club, vacillated greatly throughout the year. The first quarter witnessed the full-blown successful renaissance of the Glendale Dramatic Club, thanks in large measure to Jackie Knapp's theatrical prowess in all its aspects, and Bizzy Matthews' indefatigable financial and advertising creativity! Sherm Knapp, Ellen and Ken Bockenstette created a fabulous set worthy of Broadway. If you missed the magic that Jackie produced with the local "talent" in Cocktails with Mimi, don't let this February's production of The Second Time Around slip by!

"Dinner of the Month" continues to appeal to members of all ages and special thanks go to Lynn and Jack Murray who chaired the events for the first half of the year. In June the Murrays handed the baton to Diane and Tom Todd who are admirably maintaining the level of excellence that these monthly gatherings provide, hairy legs and all!

The second quarter did not enjoy such resounding success with respect to member participation. The Spring Dance did not generate much attendance and has only been moderately successful for several years. The Easter Bunny would have had a difficult time with his eggs were it not for staff involvement. What changes are necessary to remedy this? Other Lyceum entertainment functions experienced a marked lack of involvement by members on the organizing committees. Jane Jackson and Cindy Taylor efficiently executed these annual functions, but there has been a drop in the traditional levels of participation by members. What can be done to turn this back around so that members actually perform the creative and cooperative tasks of the former fun-filled committees?

Beginning in March, the IRS audit had us worried for several months about the Lyceum's tax liability, but the financial impact after much ado proved to be very slight. One lasting consequence of the resolution of this issue was a decrease in Non-Member rentals booked for 1999. Fewer outside rentals translates to lower than usual revenue to cover operating expenses. This cash shortfall, plus the fact that dues have not been raised in three years, prompted the Board to initiate a modest increase of \$7.50 per quarter for Senior members; \$5.00 for Retired, etc. effective April 1. Considering that the cumulative rate of inflation over these three years is greater than the 6.7% dues increase, this decision merely offsets the decreased value of money.

Third quarter events were mostly fun-filled: sunny days at the pool, enhanced by Jane's and Carol Faulkner's innovative management, and highlighted by the initiation of the Lyceum's first swim team in years; Kids' Camp kept our wee-ones entertained and Jane and the teen/counselors hopping! Our "summer" theatre featured a successful children's production staged by Nancy Green and Sue Worachek. The tennis courts were too often empty throughout the summer, but the annual club tournament on the Fourth was a great day for participants and spectator's alike.

The Task Force proposed by Joe Hubbard last January to thoroughly study the operations of the Lyceum was postponed until the third quarter. This was due to the tax dilemma that created a limbo-like state of affairs for several months and that made uncertain the Lyceum's future operational requirements. Joe chaired this committee with Cindy Taylor, Randy Parks, Angie Larimer and David Montgomery. The objectives of the Taskforce were to 1) study manpower needs; 2) review the effect of rentals on manpower and costs; 3) recommend alternative approaches for a) assuring that adequate resources

are provided and b) providing a cost-effective staffing structure; and 3) provide other recommendations identified during the review. The committee conducted many hours of thorough data analysis, in-depth staff interviews and conversations with a cross section of the membership. The Taskforce concluded that the staffing levels are adequate and necessary to operate the Lyceum at its present levels of activities and to properly maintain the overall condition of the facilities.

As I mention the staff, it is important to acknowledge the faithful and professional performance of their duties. Jane's name has already been mentioned frequently in this report and her presence and involvement in ongoing member events is obvious. Some of you find it easier to communicate your thoughts with her than to the Board directly and I am grateful that she can perform this valuable function as member-liaison. Judy Hummer, our Business Manager, provides the energy that remarkably and dependably coordinates and drives the many other facets of the Lyceum. Judy has kept the club's center intact through these past four years' various crises. beginning with the Lyceum 2000 renovations and continuing through the extraordinarily busy rental schedule of these last two years. In fact, after the Maintenance Director took another job in November, Judy and Jane, along with Audrey Weber, manned all the functions so that the operations could continue relatively unaffected.

The last quarter of this year was highlighted by the annual Directors' Ball which was attended by 235 members and guests. Special thanks go to my Art Deco Committee: Louise Allen, Ellen Bockenstette, Jeanne Green, Cathy Hubbard, Lynn Murray and Lydia Rittinger. Without all their help, the Ball would never have achieved such elegant success. The elegance continued throughout the holidays, begun by the

gorgeous Christmas tree donated by Wich and Marlin Ach. The new decorations throughout the club were spectacular this year due to Carol Faulkner and her committee, with Candy Ryan's tremendous contribution of time and effort in installing everything!

Lastly, I would like to thank all the members who have proposed new members to join the Lyceum this year and in recent years. This function is crucial to the on-going viability of the club. Everyone needs to become an advocate for increased membership recruitment so that the Lyceum can enjoy the renewed vitality that new members bring!

TREASURER'S REPORT

The Lyceum year of 1998 was a busy year from a financial point of view. We were audited by the IRS in early 1998, which was a traumatic experience for a new Treasurer. We involved outside Legal Tax specialists for tax advice on this subject. The Lyceum is very fortunate to have members like David Hamilton to depend upon for his advice and that of his partners at Deloitte and Touche. Thank you very much David!! The audit resulted in the loss of our federal tax NON-PROFIT status. The amount of income from Outside Nonmember rentals as a percentage of Total Income was considerably above the allowable figure. The judgment resulted in a small fine of about \$900. Outside Legal Counsel and the CPA advisors feel that this loss of NON-PROFIT status will have very little financial impact on the Lyceum. This whole IRS audit and the subsequent investigation was a rude awakening for this Lyceum Treasurer, who has primarily been involved in Sales and Marketing responsibilities in the past.

The next major event was the negotiation of a revised rate for the Lyceum loan. Due to the reduction in the Fed interest rates, we shopped the local banks and were able to reduce the interest rate on our loan from **8.25% to 6.95%** fixed. This results in a sizeable reduction to our annual principal and interest payments.

In 1998 the Initiation Fees were down considerably from 1997 (-\$10,920). The Non-Member Rental income was off by (-\$12,420) from 1997. The net result of Entertainment income and expenses was a great improvement, going from (-\$10,510) to (-\$1,030). Great job Cindy and the various Entertainment Committees. The Director's Ball continues to cost about \$10,000. Increased activity at the Pool, plus Carol Faulkner's Flea Market sale of used equipment yielded increased revenue in the Pool area. The Net income from the Kid's Camp and Dinner of the Month, have turned the YED to positive figures. Congratulations to Jack Murray, Jane Jackson, and the Kid's Camp Director and all the DOM committees for a great job in 1998.

OPERATING EXPENSES - The employee-related expenses increased approximately \$7,700, because of the increased use of the Caretaker for some maintenance projects, the use of part-time personnel for tennis court/general maintenance and modest salary increases for staff personnel. Our Federal taxes were down because of a tax refund, but the Property Taxes are up 33% (+\$5,470). The Administrative costs were up in 1998, due to the Legal Consultant fees and additional printing costs. The expenses for House and Grounds were up 5%, the Pool up 5%, and Sports up 16%. These increases were due to break downs of equipment and the necessary repair plus repairs to the physical structures, such as the garage.

The Capital Projects will be covered by Randy Parks.

The total amount of P&G stock that the Lyceum owned on 12/31/98 was 24,090 shares with a value of \$2,199,718 vs \$1,975,883 on 12/31/97. (+\$223,835).

SECRETARY'S REPORT

This is the sixth year of the undersigned's Board tenure, this last year as Secretary.

The two best phrases contained in the Minutes and Notes to Minutes this year were:

Joe Green:

"emotional capital" – the investment that committee chairmen, volunteers, Board members and especially Presidents (and past Presidents, Board members, etc.) of the Lyceum have in the Lyceum enterprise.

Jack Murray:

"agony of debating" -- (12 times each year – i.e. at virtually every Board meeting) whether to raise dues or sell Procter in an effort to cover the budgeted expenses. This debate causes a "penny-pinching" mentality which precludes, in many cases, presentation of the best service to the Members. This term – agony of debating -- also relates this year to the time-study of Non-Member Rentals vs. Member Rentals to determine the actual cost of same. Jack had some ideas for doing away with this "agony."

Membership Report

The Table below summarizes the changes in the various classes of membership during 1998. This year we have an increase of five for the Senior Member category, the one that produces the most revenues. As Scott Brinker stated in last years Annual Report, "we clearly have outstanding facilities and superb programs that can easily support a significant increase in participation." He computed that we should enlist 15 to 20 new families annually just to maintain the current level of membership and dues in light of resignations, transfers, deaths, etc.

We wish to express, again, our thanks to those members who funded this welcome asset.

Finally, I would like to express thanks to Andy Todd, Allen Dohan, Don Houpt, and Ed Hartwig for their time and good efforts in running the various tournaments.
